

RESOLUTION 2026-01-505

**A RESOLUTION OF THE CITY OF LYNN HAVEN, FLORIDA,
APPROVING AN AGREEMENT WITH DEMOLITION PROS,
RELATING TO THE 1200-1300 MINNESOTA AVENUE SIDEWALK
PROJECT, IN AN AMOUNT NOT TO EXCEED \$99,265.**

WHEREAS, the City has requested bids for the 1200-1300 Minnesota Avenue Sidewalk Project; and

WHEREAS, the City received nine bids that were timely and fully responsive to the City's request; and

WHEREAS, Staff recommends the City enter an agreement with Demolition Pros and authorize a contingency amount of \$15,000.

NOW THEREFORE BE IT RESOLVED that:

1. The appropriate officers of the City are authorized to accept and deliver on behalf of the City that certain Agreement between the City and Demolition Pros relating to the 1200-1300 Minnesota Avenue Sidewalk Project for the base bid amount of Eighty Four Thousand, Two Hundred Sixty Five Dollars (\$84,265), in substantially the form attached as Exhibit A and presented to the Commission today, with such changes, insertions or omissions as may be approved by the Mayor and Interim City Manager and whose execution shall be conclusive evidence of such approval.
2. The Interim City Manager is authorized to execute and deliver on behalf of the City change orders for unforeseen conditions related to this Project, in a cumulative amount that does not exceed Fifteen Thousand Dollars (\$15,000), provided that the CRA Director certifies that the change order does not result in a fundamental change to the scope of the Project or the standard of materials used for such, the Finance Director confirms the contingency amount set forth herein is not exceeded, and the City Attorney has reviewed the form of the change order.
