A RESOLUTION OF THE CITY OF LYNN HAVEN, FLORIDA, APPROVING AN AGREEMENT WITH EPSS SUPPLY & FABRICATION, LLC, RELATING TO THE DEMOLITION AND RECONSTRUCTION OF STAIRS AND CATWALK AT THE CITY'S WASTEWATER TREATMENT PLANT, IN THE TOTAL AMOUNT OF \$52,250.00.

WHEREAS, the City has solicited three quotes for the demolition and reconstruction of the stairs and catwalk for the City's Wastewater Treatment plant, in accordance with Section 4.05.1 of the City's Procurement Policy; and

WHEREAS, Staff recommend the City enter an agreement with EPSS Supply & Fabrication, LLC, the lowest responsive and responsible bidder.

NOW THEREFORE BE IT RESOLVED that the appropriate officers of the City are authorized to accept and deliver on behalf of the City that certain Agreement between the City and EPSS Supply & Fabrication, LLC relating to the demolition and reconstruction of stairs and catwalk for a tank at the City's Wastewater Treatment Plant, for the total amount of Fifty Two Thousand, Two Hundred Fifty and 00/100 Dollars (\$52,250.00), in substantially the form of the quote attached as Exhibit A and presented to the Commission today, with such changes, insertions or omissions as may be approved by the Mayor and Interim City Manager and whose execution shall be conclusive evidence of such approval.
